Airbus Flight Simulator Experience – December 2022

[Deadline extended. Updated information in brown,]



Airbus A320 Static Flight Simulator to be used in the event.

Flight simulator allows participants to apply and consolidate flying theory learnt in textbooks and ground school, and to further develop knowledge, skills and attitude conducive to flying operations in a safe training environment irrespective of participants' experience. It has been used in a number of aviation education programmes in the Corps, including Advanced Aviation Education Programme, Operation Kingbird and Qualified Aviation Instructor Course.

2. With the sponsorship from the **Community Chest**, Aviation Education Wing has communicated with a flight simulator service provider and secured a number of seats for the captioned event, with the following details.

(a)	Mass Briefing Date & Time	10 December 2022 (Saturday) 0900-1100 or on demand <i>Remarks: The mass briefing will be recorded and available on demand. Participants may attend any time prior to the assigned flight simulator time slot.</i>

(d)	Flight Simulator Venue	Airport*
(e)	Exercises to cover in Flight Simulator	45 minutes hands-on flying on an Airbus A320 static flight simulator. Throughout the hands-on flying, participants will be instructed by a commercial pilot.
(f)	Fee	Free of charge. However, see paragraph 3 for more information.
(g)	Eligible Members	All members. Priority allocated to cadets as detailed in paragraph 6.
(h)	Quota	40
(i)	Dress Code	To be confirmed

[^]AE Wg will endeavour to assign the timeslots with reference to applicants' preferences.

*The exact venue will be provided in the joining instructions.

3. Once admitted, participants are required to attend the mass briefing and the flight simulator experience as assigned. Participants who failed to attend the mass briefing **prior to the assigned flight simulator time slot** will be discontinued from the event. Participants who are discontinued or otherwise absent on the experience day without a legitimate and compelling reason will be required to pay **HK\$1,000** to the Corps for cost recovery. Whether a reason provided is legitimate **and** compelling will be determined by Aviation Education Wing with due consideration of the supporting documents available.

4. Participants are encouraged to have a self-study / revision on Principle of Flight and Effects of Control before joining the mass briefing. The following Youtube videos could be useful references:

5. Interested members are invited to apply through their OC Units. OC Units (or their delegates) should submit the applications by (1) (for slots on 10 and 11 December) 8 December 2022 or (2) (for other slots) 5 calendar days in prior using the following Google Form:

6. In case the number of applicants exceeds the quota, seats will be allocated according to their availabilities and in the following order:

- a) Cadets aged 16 or below, as of 10 December 2022;
- b) Cadets aged 17 or above, as of 10 December 2022;
- c) All other members.

7. All applicants shall possess the Vaccine Pass (疫苗通行證) and present it when requested, unless they are exempted. The details of the Vaccine Pass are available in a Government poster (Link: [English](#) / [Chinese](#) version), and the details of persons exempted are available in another Government poster (Link: [English](#) / [Chinese](#) version).
