Online Commercial Pilot Licence Course Sponsorship Programme

This memo supersedes my previous memo with reference (8) in AE/OPC dated 2 June 2022. Details different from my previous memo are highlighted in brown.

2. With the sponsorship from the **Community Chest**, the Aviation Education Wing has launched a sponsorship programme for members to attend an online private pilot licence (PPL) course and received decent responses. We are glad that the **Community Chest** has decided to extend the sponsorship, and the Aviation Education Wing is now offering a sponsorship programme for members to attend an online commercial pilot licence (CPL) course.

3. The *Sporty's Commercial Pilot Training Course* follows the United States Federal Aviation Administration (FAA) Commercial Pilot Certificate (equivalent to CPL) syllabus and contains 13 hours of in-depth video training to prepare the students for the FAA knowledge test on Commercial Pilot – Aeroplane (CAX). The training content is organized by subject into six main chapters: flight manoeuvres, weather, performance, high altitude systems, navigation and regulations.

4. Details of the Sponsorship Programme are available as follows:

Period of Study	From course fee settlement (expected in mid-August 2022) until 10 March 2023
Course Fee	HK\$2,200 (The course fee will be reimbursed in full upon successful completion of the course.)
Quota	10

Eligibility	<p>All members. However, considering the complexity of the course content, the following members will be considered with priority:</p> <ul style="list-style-type: none"> - Graduates of AAEP, AAEP(H) or QAIC - Graduates of the Online PPL Course Sponsorship Programme - Holders of PPL issued in Hong Kong, or equivalent

5. Selected members shall first settle the course fee in full with HKACC HQ. They are then required to complete the course within the aforementioned period and submit proof of completion* before the deadline. They will then be reimbursed **in full**. The administration arrangement will be communicated to the successful applicants.

*Remarks: The proof of completion shall comprise a record of attaining pass results in the final test for two times. There is no limit set on the number of final test attempts.

6. More information about the course is available through the [official website](#) of the training provider. Applicants shall have access to a computer, a smart phone or a similar digital device with internet access so as to view the course content.

7. Applicants may be required to go through a selection exercise including essay-writing and an individual interview. The interview serves to assess the applicants' English ability, knowledge up to PPL level and passion in aviation, and is tentatively scheduled for **13 / 14 August 2022** (Saturday / Sunday). Details of the interview will be confirmed in due course.

8. Interested members shall submit their applications via their OC Units using the attached application form. The form shall reach OC AE Wg through email (hkacc.aewing@gmail.com) on or before **31 July 2022**. Those members who have applied on or before 17 June 2022 through my previous memo (7) or (8) in AE/OPC will automatically be put into the selection exercise of this round, and therefore need not reapply.
